

**Central CT Catholic Middle School Basketball League
Varsity Assignment Agreement
6A Assignments Company

This agreement covers the New Britain, Greater Hartford, and Meriden Deaneries, in the Central CT Catholic Middle School Basketball League for the 2011-12, 2012-13, 2013-14 seasons.

- 1. The assignment fee from each school is \$125.00. Schools that sponsor a tournament will pay \$150.00. This fee provides assignment of officials for league and non-league games. \$25.00 late fee if not paid by November 15th each year.**
- 2. Official's fee shall be \$55.00 per official. The fee for two games, second game starting not later than 10 minutes after the first game shall be \$84.00 per official. Three games (at least one of which is six minute periods) each starting not later than 10 min after previous game shall be \$108.00 per official. Four games, each starting not later than 10 minutes after the previous game, two of which are 6-minute periods shall be \$132 per official. Schools can negotiate fees for special tournaments: pre, post or during the season. Fees will remain constant for 2012-13 season, and will increase by \$2.00 in the 2013-14 season.**
- 3. Officials for Varsity post-season games will be paid by the League at the single game rate in effect for that year. The final game rate is plus \$10.00. Officials for Junior Varsity post-season games are \$5 less than the Varsity rate.**
- 4. High School Federation Rules as modified by the CIAC, shall govern all play, except as modified herein.**
- 5. League Varsity games are 7-minute periods. Overtime will be 3 minutes. Varsity halftimes are no more than eight minutes, seven on the clock, started immediately at the conclusion of the second period. Junior Varsity games are 6-minute periods. JV halftimes are no more than six minutes, five on the clock.**

6. In the event of postponements for any reason within 24 hours of scheduled start time, the home team AD is responsible to notify 6A Assignments Company not less than three hours prior to the scheduled start of the first game by contacting Bob Gunning on his cell phone at 860-882-2887. Postponements or cancellations for future games (more than 36 hours in the future) can be communicated via email to bobgunn@aol.com with a cc to ccmarotta@yahoo.com. Cell phone calls are always accepted. Failure to contact 6A Assignments Company will result in full payment to the officials.

7. The 6A Assignments Company shall assign two officials for each home game. The Company shall be the sole judge as to the competence and availability of such officials. If one official works a game, the fee is 1 1/2 that of the regular fee.

8. If an official reports more than fifteen minutes late, there could be a \$7.00 reduction in their fee, as determined by the host AD. If later than half time, no fee for that game, other official receives 1 1/2 fee.

9.. If games start late, other than because of length of previous game, the compensation shall be: after ten minutes, an additional \$10.00 fee per official, after 20 minutes additional \$15.00 fee per official. Games are forfeited after 30 minutes.

10. Schools agree not to solicit; and the Commissioner and officials agree not to participate in any raffle, contest, drawing, booster club or other fund raising event.
